#### **MISSION**

IBC Australia's Mission is to bring international businesses, corporations, governments, non-governmental and non-profit organisations, business councils, chambers of commerce and industry, associations, etc., together to achieve a common goal of development and supports disadvantaged people and relieving distress caused by natural disasters and sudden catastrophes.

#### Membership

Any natural person who is over 16 years is eligible to become a member of the Association who has an interest to promote and advance the aims and objectives of the Association.

Only individual members or persons eligible to become a member are eligible to become the life member of the Association. All paid members are eligible for election as an officer of the Association and shall have the right to vote at the general meetings.

The Executive Committee may appoint any person as an Honorary Member or Patron who have rendered special or outstanding service to the Association or elsewhere. Honorary Members shall not be entitled to vote at any general meeting or Committee meeting unless they hold office as a member of the Committee.

The Executive Committee may admit based on the merits any organisations/business/enterprise/association/NGO/government department/agency, etc. as a Corporate member, Association/NGO member or the Government Agency/Department member of the Association.

The Executive Committee shall consider each application at an Executive Committee Meeting and may accept or reject that application without assigning any reasons.

The annual subscription shall be payable within 31 days of each calendar year (before 31 July) and shall be such sum as may from time to time be determined by the members at an annual general meeting.
